In 2019, we have been truly blessed by the Lord as we were able to extend our reach into the community through an expanding network of senior care centres and, a first for us, a nursing home.

TRANSFORMING CARE

We have grown tremendously since 1999. Beginning with four senior care centres, we now serve elders and their caregivers from 23 centres islandwide. We have moved beyond day and home care, opening a nursing home, St Luke's ElderCare Residence @ Ang Mo Kio, in May 2020. Our staff strength has similarly risen significantly over the past 20 years, from less than 50 to 577 staff as at 31 March 2020.

Beyond these numbers is our drive to transform elder care in Singapore by engaging and empowering elders through purpose-built spaces, and through services, programmes and activities that draw on best practices and innovations from around the world. Our motto, "No one ages alone at SLEC", takes our missional calling beyond caring for the body to include soul and spirit! This is how we seek to make a difference beyond the physical. We cannot accomplish these without the help of our partners, volunteers and the many generous donors who helped to keep us financially sustainable.

The onset of COVID-19, and the national Circuit Breaker, greatly tested our capacity to deliver our services. Our staff, the elders from our centres and their caregivers responded with creativity and resourcefulness. We resolved that our elders deserve uninterrupted care even under such challenging circumstances. Our staff made use of online tools, devised new ways of delivering day and home care, and kept our elders engaged during the Circuit Breaker. Staff were also able to continue their training and orientation programmes by leveraging on eLearning and online training.

NURTURING OUR CAPABILITIES

To foster a learning culture, we have consistently sent our staff for training, and brought in industry experts to increase our nursing capabilities and knowledge of care. We have also spared no effort in training our team of care partners and allied health professionals, which include social workers, dietitians, therapists, nurses and doctors.

I am pleased to report that we are now a Learning Hub, which is a training provider appointed by the Agency for Integrated Care. We are grateful for this avenue to support the training needs of those in the community care sector. During the financial year, we had over 419 trainees in courses where they acquired knowledge and skills that are transferable anywhere within the sector.

We have also seen new departments formed and existing ones evolved. During the financial year, we introduced the Pastoral Care and Church Partnerships department to strengthen our pastoral care and support to enable us to better care for our elders, caregivers and staff.

SERVING AS ONE

While developing care capabilities remain a priority for us, we also place great emphasis on crafting programmes to engage our elders and community in innovative experiences. We do so by forging meaningful partnerships and collaborations with corporate and community partners. We are truly thankful for their support in formulating ideas and encouraging volunteerism. We would not have been able to make such a great impact in the community without them.

I would also like to acknowledge another group of volunteers: our Board and Functional Committee members. They have constantly aided in establishing high standards of corporate governance, transparency and disclosure.

UNITING IN CARE

We also benefit from our strong and enduring links with the St Luke's ecosystem of health and care services. St Luke's Hospital in particular has been a source of strength. The continued work of bridging clinical care with community-based support for elders has led to invaluable collaborations and crosspollination of ideas and experiences.

Lastly, I would like to extend my sincere appreciation to Ms Jacqueline Poh. In April 2020, she relinquished her role as Deputy Chairman to chair the Programme, Services and Care Risk Committee. Her leadership and invaluable contributions have been instrumental in the development of the operations and administration of SLEC. I would also like to take this opportunity to welcome Prof. Ho Yew Kee who has stepped up as Deputy Chairman. I believe that his wealth of knowledge and experience will continue to lead us to greater heights.

Moving forward, bearing in mind the changing demographics of our elders, we will strategically look to unlock and develop programmes and services to meet the growing needs of elders in our community. We ask for your continuous support as we pursue our vision to transform community care.

On behalf of our board, elders, caregivers and staff, we praise God who is our Provider and Anchor and we thank you for devoting your time, talent and resources in caring for our community.

CEO'S MESSAGE



EMPOWERING OUR ELDERS

In March 2020, we moved into our first nursing home, the 189-bedded St Luke's ElderCare Residence @ Ang Mo Kio (SLR@AMK), with the vision of creating a home away from home for our elders, incorporating an approach that sees elders empowered to be agents and not just recipients of care.

The same empowerment mindset is realised in the inclusive community spaces at our newly renovated senior care centres and five new senior care centres, where the design and programmes have been improved to support greater independence and participation by elders in their own care and the care of others. We realised a first with the opening of Ang Mo Kio Polyclinic Centre in April 2019. It is the first senior care centre in Singapore to be sited within a polyclinic, offering elders same-location convenience for care services and medical follow-ups.

LIFTING UP OUR PEOPLE

Key to unlocking potential is the notion of learning as a lifelong journey. In the run-up to the opening of our SLR@AMK, we intensified training to ensure that our Philosophy of Care permeates our people, facilities and programmes.

Our Learning Hub, designated as one of six Learning Institutes appointed by the Agency for Integrated Care to provide training for the community care sector, also continues to expand its capacity, training over 500 staff and 419 community care participants.

We are proud of our staff who bring a heart for our elders and a drive for excellence that were recognised through awards and accolades in day care, active ageing, dementia care, human resource practices, organisational leadership and service quality. We are particularly pleased to be recognised for Best Dementia Care at the 7th Asia Pacific Eldercare Innovation Awards.

ENERGISING OUR PARTNERSHIPS

The year also saw meaningful collaborations with schools, churches and the public and private sectors in enhancing links with the wider community, developing programmes and raising funds. Further, in November 2019, we established a Pastoral Care and Church Partnerships department, which is already forging new partnerships while strengthening existing ones.

ANTICIPATING CHALLENGES

In the next year, COVID-19 will likely continue to be a concern. But as the past months have shown, we will continue to rely on our reserves of capacity, creativity and flexibility to develop and adapt services and programmes to meet changing realities.

St Luke's Hospital: 2019 in Brief

The St Luke's ecosystem includes St Luke's Hospital, a 243-bedded community hospital committed to outstanding care.

In financial year 2019, St Luke's Hospital had more than 2,300 inpatient admissions, caring for patients who need rehabilitation, wound, dementia or palliative care. The hospital also served more than 3,800 outpatients through St Luke's Community Clinic, the day rehabilitation and home care. It achieved a 95% patient satisfaction rate, Serving, Loving and Healing patients through the 4Rs (Responsive, Reliable, Responsible and Relational). Its staff has won awards and accolades for their committed care for patients within the hospital and in the community.

St Lukes

Collaborating with almost 100 partners, St Luke's Hospital worked with organisations such as Fei Yue Senior Activity Centres (Bukit Batok) to prevent frailty in the community through Jin Jia Ho!, a community health programme. There was improvement in the seniors' physical strength and vitality, and increased social interaction through centre-based activities and active monitoring.

St Luke's Academy also conducted courses on subjects such as wound and dementia care for 770 staff from hospitals, nursing homes, and organisations in the community care sector.


BOARD OF DIRECTORS

PROFESSOR HO YEW KEE


Director

CORPORATE GOVERNANCE

St Luke's ElderCare Ltd is fully committed to living its core values in all its activities. Its core values are captured as CHRIST which stands for Compassion, Holistic Excellence, Respect, Integrity, Stewardship and Teamwork. It upholds the highest standards of corporate governance and complies in all material aspects with the corporate governance regulations, code and guidelines established in Singapore.

Audit, Risk and Governance Committee

The Audit, Risk and Governance Committee comprises Mr Choo Eng Beng (Chairman), Mr Ho Kuen Loon, Mr Ho Tuck Chuen, Dr Yap Chee Meng and Mr Yeo Ek Khuan. All Committee members have recent and relevant accounting or related financial management expertise or experience. The Committee assists the Board in fulfilling its oversight and fiduciary responsibilities to act in the interest of St Luke's ElderCare.

The Committee's responsibilities include overseeing:

- the integrity of the financial information presented to the members, Board, regulators and the general public
- · the work of internal and external auditors
- major operational, financial and business risk exposures
- corporate governance policy and processes
- the Ethical Disclosure Policy
- any other matters as may be defined by the Board

The Committee undertakes an annual assessment regarding the adequacy and effectiveness of the management systems and internal controls. They are assisted by external auditors Moore Stephens LLP and internal auditors Baker Tilly TFW LLP to perform this review. Internal controls review includes financial, operational, compliance and information technology controls.

In the financial year under review, the Committee met three times in carrying out its responsibilities including the review of the audit works and recommendations by both internal and external auditors. The audit report for this financial year concluded that the financials reporting therein gives a true and fair view of the financial position of St Luke's ElderCare in accordance with statutory requirements and the internal controls established by Management were adequate and effective to meet the needs of the organisation in its current operational environment.

The Committee will continue to ensure the highest possible level of organisational integrity within St Luke's ElderCare.

Finance, Investment and Procurement Committee

The Finance, Investment and Procurement Committee comprises Ms Ginger Hsiao (Chairman), Mr Lee Chee Yeng, Mr Wan Kum Tho and Mr Yeong Zee Kin. All Committee members have recent and relevant finance or investment management expertise or experience. The Committee provides advice to the Board and reviews the financial performance, annual budget and expenditure of St Luke's ElderCare with the aim of:

- approving investments and other financial matters
- overseeing annual budget preparation
- reviewing and approving selected procurements including tenders
- updating the Board of Directors on financial decisions made

In line with its mandate, the Committee met four times to review project tenders, the annual budget and investment matters.

The Fundraising Committee

The Fundraising Committee comprises Mr Alfred Wong (Chairman), Mr Choo Eng Beng and Mr Foong Daw Ching. All Committee members have recent and relevant fundraising expertise or experience. The Committee advises the Board and Management on fundraising matters.

The Committee provides oversight on fundraising strategies and plans, and ensures that ethical fundraising is practised.

Beyond generating ideas and providing oversight, the Committee expands the access and outreach of St Luke's ElderCare to potential donors, funders and sponsors by leveraging on the influence of its members.

The Committee keeps Board Members updated on fundraising activities. In the financial year under review, the Committee held three meetings, with all members in attendance.

Human Resource Committee

The Human Resource Committee comprises Prof. Ho Yew Kee (Chairman), Ms Lim Ai Ling, Prof. Neo Boon Siong and Mr Wong King Yoong. All Committee members have recent and relevant human resource expertise or experience. The Committee assists the Board by providing a strategic and principled perspective on the design and implementation of the human resource policies of St Luke's ElderCare.

The Committee's responsibilities include:

- overseeing appointments, development path, compensation and performance of senior management
- reviewing succession planning for key management positions
- reviewing practices related to learning, organisation development, staff engagement and retention
- setting and approving bonus and compensation packages for all staff

For the financial year under review, the Committee met twice to review the organisation's human resource objectives. Subsequently the Committee worked closely with the management of St Luke's ElderCare to ensure the successful implementation of the revised objectives.

Medifund Committee

The Medifund Committee comprises
Mrs Wee Wan Joo (Chairman), Ms Chua
Ee Cheng and Dr Wong Loong Mun. All
Committee members have the relevant
expertise or experience to ensure that
disbursements are made in accordance
with Medifund objectives and guidelines.

Specifically, the Committee is tasked with evaluating and approving Medifund and Medifund Silver applications from eligible clients and monitoring the administering of payments out of the Medifund account of St Luke's ElderCare.

The Committee assesses applications for assistance with healthcare bills. Its decisions are based on criteria such as the socioeconomic background of the applicant's immediate family members, the size of the bill incurred and the outstanding balance.

For the financial year under review, the Committee met five times. It approved disbursements to ensure that clients' healthcare bills are paid in a timely manner.

Nomination Committee

The Nomination Committee comprises Mr Timothy Teo (Chairman), Prof. Ho Yew Kee, Ms Jacqueline Poh and Mrs Wee Wan Joo. All Committee members have recent and relevant corporate governance expertise or experience to assist the Board in ensuring that St Luke's ElderCare complies with the revised Code of Governance for Charities and Institutions of a Public Character.

The Committee's responsibilities include:

- leading the process for nominations to the Board and to Functional Committees
- reviewing the structure, size and composition of the Board to ensure compliance with the guidelines of the Charity Act and recommending changes, if needed
- evaluating the skills and knowledge required for all nominees to the Board, taking into consideration the current composition of the Board
- · reviewing succession plans for the Board

In the financial year under review, the Committee met three times and reviewed the current status of the Board and its performance. In particular, the Committee examined the nominees to the Board, the structure of the Board for compliance with the Charity Act and the composition of the Functional Committees. Following the reviews, the Committee offered advice and made recommendations to the Board.

Programme, Services and Care Risk Committee

The Programme, Services and Care Risk Committee comprises Ms Jacqueline Poh (Chairman), Dr Chan Kin Ming, Adj. Asst. Prof. Kelvin Koh and Ms Carol Liew. All Committee members have recent and relevant expertise and experience with senior activity programmes and operations, which equips them to provide oversight and guidance on programme and service development to ensure consistency with the mission and vision of St Luke's ElderCare as well as in identifying, managing and mitigating care risks arising from the operations in the senior care centres, nursing home and home care.

The Committee's responsibilities include:

- providing oversight of programme and service development to ensure that they are in line with the vision, mission and objectives of St Luke's ElderCare
- providing oversight on the operational implementation of programme and service delivery mechanisms
- providing oversight on programme evaluations and service quality
- monitoring and assessing the outcomes of programmes, ensuring the clear definition of the intended outcomes of each programme
- · working with Management to identify, monitor and manage clinical, operational and administrative risks linked to our programmes, services and care
- · providing updates to the Board on the risk registers along with mitigating measures

Ethical Disclosure Policy

St Luke's ElderCare is committed to lawful and ethical behaviour in its activities, and requires that its directors, management, staff, volunteers and consultants conduct themselves in a manner that complies with applicable laws and internal policies.

In keeping with this commitment and the interest of St Luke's ElderCare in promoting open communication, its ethical disclosure policy aims to provide a means through which concerned employees can raise ethics and governance-related issues with the assurance that their identity will be kept confidential and they will be protected from reprisals or victimisation for acting in good faith.

Annual Remuneration Disclosure

In accordance with the revised Code of Governance for Charities and Institutions of Public Character 2017, it is recommended that charities shall disclose the remuneration of its three highest paid staff, who each receives remuneration exceeding \$100,000 per annum.

The breakdown for FY2019 is as follows [number of staff in brackets]:

ATTENDANCE AT BOARD MEETINGS

Renovation of Hougang Day Rehabilitation Centre

Improvements to our infrastructure enable us to better address the needs of our elders. The renovation of the Day Rehabilitation Centre at Hougang has created a safer and more supportive environment for our elders as they utilise the spaces within.

Renovation works will continue for Hougang Day Care Centre, with Whampoa and Bukit Timah Centres in the pipeline. The refitting works will also allow us to better incorporate our GRACE Philosophy of Care.

Official Opening of Kebun Baru Centre

St Luke's ElderCare Kebun Baru Centre, located within Kebun Baru Community Club, officially opened on 31 July 2019. The event was graced by Guest of Honour, Mr Henry Kwek, Member of Parliament for Nee Soon Group Representation Constituency (GRC) and Grassroots Adviser to the Nee Soon GRC Kebun Baru Division.

We were delighted to have young performers from Sunflower Preschool lead everyone in song and dance, followed by the team from Music Movercise who taught the audience how to make music with subtle movements.



On 14 October 2019, youths from various schools came together with our elders to celebrate the launch of *ONE* (which stands for Old & New, Nature & Nurture and Endings & Beginnings), a compilation of creative illustrations and writings by youths. Our elders also contributed comics and illustrations for the storybook.

South West Community Development Council: Silver Activities

Silver Activities is a structured cognitive programme that aims to keep elders mentally active, engaged and digitally savvy. This programme is made possible by the Southwest Community Development Council through the use of the South West Innovation Fund.

Our elders from the Ayer Rajah, Bukit Batok, Clementi, Keat Hong and Jurong East centres enjoyed the research-based games aimed at stimulating cognitive domains such as working memory and analytical skills through graded activities that range from simple to complex.





National Heritage Board: Heritage Trunks

On 6 May 2019, the National Heritage Board officially launched Heritage Trunks at Ayer Rajah Centre.

Heritage Trunks are a set of thematically curated trunks comprising authentic objects from the 1950s to 1980s. Aside from serving as tools to spark conversations, the trunks aim to empower and encourage interaction among our elders.

Many of our elders were elated to see the familiar items as they helped them relive experiences from their yesteryears.



Music Solutions: Performing Arts

Music Solutions works with local and international institutions to enable youths and elders to develop their interest in the performing arts through interactive musical instruments. In the past year, the team from Music Solutions has engaged with the elders at our Marine Parade and Changkat centres through karaoke sessions featuring renditions of evergreen songs.

Their team was also instrumental in grooming our staff into "stars" for our Volunteer Appreciation Day 2019 performances. The singing sessions along with the dance and vocal practices sparked many conversations between their staff, and our elders and volunteers.

Our ongoing partnership with the National Heritage Board was boosted by a virtual tour of the Sun Yat Sen Nanyang Memorial Hall in Balestier and the Indian Heritage Centre in Little India. The presentation brought back fond memories for our elders at the Changkat, Golden Years and Marine Parade centres.

The virtual tour also enabled National Heritage Board staff to touch on the rich history, culture and arts back then. We look forward to introducing a virtual tour of the Malay Heritage Centre in Kampong Glam to the rest of our centres.

Fajar Secondary School: Intergenerational Day

As part of the annual Intergenerational Games organised by Fajar Secondary School since 2012, more than 200 elders were involved in a fun-filled day put together by students with the guidance of their teachers.

We are thankful for the continuous support from the school and we are also grateful for the students' creativity and passion in creating elder-friendly games each year.



PSA Singapore: Our Food Garden

As part of a corporate social responsibility initiative by PSA Singapore, a community food garden was set up at our Ayer Rajah centre in early May 2019.

Staff from the Singapore Port Workers Union, the Port Officers' Union, and PSA Singapore's Health, Safety, Security, Environment (South East Asia) Division worked with our elders to create this garden, which featured more than 20 different types of herbs and vegetables.

New Hires' Orientation Programme

The New Hires' Orientation Programme (NHOP) has seen a steady increase in the number of runs per year since its launch in May 2017.

During the financial year, we organised 11 NHOP runs to ensure our staff are equipped with the skills needed to care for our elders. These runs also enable us to impart our Philosophy of Care to our staff, ensuring our care approach is consistent throughout the organisation.

Scholarships

This year, four scholarships were awarded to our staff to support their higher education. Scholarships were given for the following programmes: Specialist Diploma in Facility and Energy Management, Master of Gerontology, Bachelor of Science in Physiotherapy.



Learning Hub: An AIC-Appointed Learning Institute

Our Learning Hub is one of six Learning Institutes appointed by the Agency for Integrated Care (AIC) as a training provider in developing, delivering and administering training courses for the Community Care Sector.

Our team is proud to have trained a total of 419 external participants during the financial year. This is an increase of 150 percent from the 164 trainees served in the previous year.

Three-Year Specialist Diploma: Collaboration with Temasek Polytechnic

In August 2019, we partnered with Temasek Polytechnic to offer the Specialist Diploma in Gerontology (Optimal Ageing Practice), where 10 of our subject matter experts were appointed as Practicum Supervisors to mentor and guide the students in their internship projects.

This partnership enables us to impart our knowledge and experience to individuals and groups in and out of the sector while we continue to build a stronger community of care for our future generations.

Sharing Sessions with Foreign Scholars: Collaboration with Temasek Foundation International

As part of a collaboration between St Luke's ElderCare and Temasek Foundation International, 29 foreign scholars aged between 19 to 24 years old learned about the different cultures, customs and languages in Singapore through sharing sessions with our elders.

ENHANCING OUR CARE CAPABILITIES

As part of our efforts to deliver holistic care, we set up a new department to focus on pastoral support to our elders and staff.

Pastoral Care and Church Partnerships Department

Pastoral Care and Church Partnerships was established in November 2019 to focus our efforts on providing pastoral care and support to our elders and staff.

The formation of the department was timely as we were beginning to receive elders who require residentialbased care at St Luke's ElderCare Residence @ Ang Mo Kio.

The team continues to forge partnerships while maintaining existing collaborations with the church partners supporting our network of senior care centres islandwide.

Director of Nursing and Academic Director at St Luke's ElderCare

Assoc. Prof. Poon joined St Luke's ElderCare in 2017. He graduated from the University of Sydney with a Bachelor of Health Science Nursing in 1998, obtained his Master of Science in Palliative Care at King's College London in 2002 and a Doctor of Philosophy from Monash University in 2013. In 2014, he was recipient of the Healthcare Humanity Awards and the President's Award for Nurses in Singapore.

Leveraging on his extensive knowledge in palliative care, he has volunteered to teach the subject in Malaysia, Myanmar, Cambodia, Thailand and Taiwan.

He has also contributed to research and community care outreach programmes locally and abroad while working with the National Nursing Taskforce and the National Palliative Care Taskforce.

In his capacity as Academic Director, he oversees the development and curation of the training curriculum and programmes to ensure relevance and application to our various settings and care needs. He also plays a significant role in building our Philosophy of Care into our course curricula and delivery.

Currently he is working with Ms Ng Lay Ling, Head of St Luke's ElderCare Residence @ Ang Mo Kio, as well as with Sister Susie Goh, Master Trainer with St Luke's ElderCare Learning Hub, the nursing team and our care partners to harness our potential and further enhance our care approaches.



People

Our staff are trained and encouraged to be respectful and conscious of the language we adopt across our senior care centres and nursing home.

We also respect our elders' feelings and preferences by looking into the terminologies we use to address them.



Place

Across our senior care centres and our nursing home, our spaces are designed to create an environment that enables and empowers our elders of all ages and abilities. For example, at our nursing home, we designed common areas with segregated spaces to enable and encourage interaction between our elders, staff, volunteers and visitors.

Programme

Our approach in crafting programmes incorporates our elders' inputs, suggestions and feedback as we encourage and empower them through suggestion boxes and social interaction.



WORKING THROUGH COVID-19 IN PHASES 1 AND 2

Whitelisted Centres

We continued to serve elders in the community who did not have adequate family support and required intensive custodial care while our senior care centres were closed.

In line with Ministry of Health directives, our senior care centres were closed between 7 April and 4 May 2020. The exceptions were Hougang Meadow Centre followed by Rivervale Centre which had been whitelisted by the Ministry of Health.

We are grateful for the opportunity to continue caring for our elders in the community during these times.

Continuous Engagement with Our Elders

When the "circuit breaker" phase of the COVID-19 response was announced, our team prepared home-based learning activities and care packages for our elders to ensure they remain engaged at home. In addition to hardcopy activity sheets, our team also focused on building a repository of video content comprising rehabilitation exercises, art and craft sessions, and daily orientation clips.

We are proud that many staff stepped up as Care Ambassadors to keep in touch with elders and caregivers via Zoom, Facebook and YouTube channels, and we are grateful for the appreciation shown by their caregivers as well.

Maintaining Support for Our Staff

Recognising the need to assure and provide a supportive environment for our staff, management sent care packs containing thermometers, masks, sanitisers and words of encouragement. These care packs were provided prior to the start of the circuit breaker period.

During the circuit breaker period, management continued connecting with staff through weekly devotional messages and eCare packages such as online food youchers.

Stepping Up of Precautionary Measures

Online forms for temperature taking and contact tracing were introduced across our headquarters and senior care centres, and at our residential facility in Ang Mo Kio.

Our staff at St Luke's ElderCare Residence @ Ang Mo Kio also donned personal protective equipment as an added precautionary measure in addition to maintaining high levels of cleanliness throughout.



Empowering Elders, Engaging our Heroes

Prior to social distancing measures and the circuit breaker being put in place, our elders at the centres designed postcards with personalised thank you messages to express our appreciation for our Public Health Preparedness Clinic healthcare heroes.

Our elders' efforts were appreciated by many as doctors responded by taking selfies with their staff before tagging us on Facebook.
