AN UNPRECEDENTED YEAR TESTED BY A GLOBAL PANDEMIC WITH SLEC RISING TO THE OCCASION AS WE AND THE WORLD GRAPPLED WITH THE EVOLVING DISRUPTIONS

It was a year of many 'firsts' for SLEC.

For the first time in the history of SLEC, we temporarily closed all our eldercare centres except one when Singapore went into a circuit breaker in April 2020. The rapid deployment of new technology and the fast-tracking in training for our staff in the use of technology became our "new normal".

The circumstances of the past year have truly tested our purpose for ministry. I observed, with a grateful heart, how God's works were accomplished through the innovative team spirit and tenacity of our supporters and staff. Their resolve and resilience enabled the continuing care for our elders, caregivers and communities.

The pandemic has allowed SLEC to achieve a new level of cohesive teamwork and the formation of a multidisciplinary team to handle exigencies. The team is ever ready to tackle the evolving pandemic situation. The pandemic has enabled SLEC to be united and motivated by a greater determination and purpose – to keep our elders safe, to support their family members and to continue offering meaningful engagement to our elders even when they could not come to the centres. During this challenging year, we have continued to receive affirmations from family members, as well as external accolades for our staff and programmes.

God has allowed us to courageously open St Luke's ElderCare Residence @ Ang Mo Kio (SLR@AMK), our first 189-bed residential care facility, at the start of the pandemic. SLR@AMK immediately became a channel of blessing upon opening. It was mobilised to host residents of another nursing home affected by COVID-19 and serve elders and families in the vicinity. One year after opening, we reached 82% occupancy.

Despite the fact that onsite partnership engagements and fundraising efforts had to move to virtual platforms, new online giving channels were added for donors to donate more conveniently. We are grateful that more volunteers and supporters came forward to help raise funds for SLEC.

SLEC has-inhouse training staff with extensive experience, credentials and industry knowledge. This has allowed our Learning Hub – SLEC's training arm for the sector and our partners – to experience healthy growth in its training reach. As a result, we were re-appointed by the Agency for Integrated Care (AIC) as one of the Learning Institutes (LIs) for a second term. This will further empower the Learning Hub to develop and deliver training courses for the community care sector.

Our holistic care and outreach for elders, caregivers and staff were also strengthened through the establishment of our Missional Care Committee (MCC) in 2020. The MCC supports the Board of Directors in fulfilling SLEC's missional calling.

CHAIRMAN'S MESSAGE

The end of this financial year also marked the end of my term as the Chairman of the Board of St Luke's ElderCare. I am thankful to the Board, management, staff and volunteers for your faithful service, dedication, commitment, and impactful contributions.

Collectively, God has used you to lead SLEC to excellence in service and effectiveness in our care programmes whilst obeying our missional calling to share the love of Jesus. We have demonstrated to our elders that they do not need to age alone.

As we grow and develop our services to become more impactful, let us always remember that we are but channels of the Lord's blessings. We are stewards of the grace He has placed in our hands. We touch lives through God's Spirit in us.

It has been an honour and privilege serving with all of you. As I thank you for the support you have given me all these years, I also ask that you extend the same and more to our new Chairman, Professor Ho Yew Kee, in the next phase of SLEC's journey.

2020-2021 WAS A YEAR OF ADVERSITY BROUGHT ABOUT BY A PANDEMIC. THE EFFECTS OF WHICH STILL ECHO AMONG THE COMMUNITIES WE SERVE - OUR ELDERS, CAREGIVERS, PARTNERS AND STAFF. AGAINST THIS BACKDROP OF UNCERTAINTY, BEING HOME-BOUND AND WITH PHYSICAL RESTRICTIONS ON PROVIDING CARE FOR OUR ELDERS, IT WAS ALSO A YEAR OF OPPORTUNITY.

While our methods of reaching out to our communities changed, our commitment and responsibility did not waver. We are thankful that the adversity spurred creativity and helped birth many more ways to digitally provide meaningful engagement and continued care using technology. One such way was through our award-winning Together@SLEC initiative that brought the SLEC family together to continue to engage our elders purposefully, as well as bring some relief and support to their caregivers.

Building on our existing models of care, we continued strengthening our current senior care ministry and nursing home models to grow in our quality of care. Our first residential care facility, which opened in the midst of the Circuit Breaker, is placed to go beyond the basic nursing home care, by providing integrated care as an Integrated Operations Provider. Within this model. SLEC also delivers centre-based, home-based and communitybased services in addition to our residentialbased services.

Our first Active Ageing Hub (AAH) in Bishan, slated to open in phases from 1 October 2021, will provide active ageing programmes, day care, day rehabilitation and assisted living services for the community. Through proactive outreach, the AAH will take on a partner-led approach to curate programmes that actively reach out and benefit the Bishan community.

Our partnerships continued to bear fruitful engagements via virtual means and gave rise to many meaningful stories and exchanges through partnerships with our communities, churches, educational institutes, government agencies, schools and social enterprises.

Our Learning Hub, an appointed Learning Institute (LI) by the Agency for Integrated Care (AIC), continued to contribute to sector growth to support the ageing population. We have been given an increased number of training places in specialty areas including Palliative Care, Dementia Care and Wound Care. The pandemic has also presented the opportunity for e-learning to be accelerated and will continue to be another channel of our training delivery. As we continue to grow in the coming year, it is also our priority to build the internal capabilities of our workforce to meet the needs of the elderly population.

2020-2021 has been a fruitful year for SLEC. This is possible with the support on many fronts from our various partners and staff who showed great resilience and compassion during challenging times. As we pivot towards a technology-led landscape and innovative models of care, I invite you to continue to join us on this journey and work alongside SLEC to shape the next generation of care.

He was recently appointed Director of Singapore Network Information Centre (SGNIC) Pte Ltd. Prior to that, he was Senior State Counsel (Director, Technology) at Civil Division, Attorney-General's Chambers.



CORPORATE GOVERNANCE

St Luke's ElderCare Ltd (SLEC) is fully committed to living its core values in all its activities. Its core values are captured as CHRIST which stands for Compassion, Holistic Excellence, Respect, Integrity, Stewardship and Teamwork. It upholds the highest standards of corporate governance and complies in all material aspects with corporate governance regulations, codes and guidelines established in Singapore.

The Nomination Committee examines the nominees to the Board, the structure of the Board for compliance with the Charity Act and the composition of the Board committees. Following the reviews, the Committee will offer advice and make recommendations to the Board.

Its Board of Directors are encouraged to attend training programmes, seminars and workshops organised by professional institutions, to keep apprised of relevant laws, regulations and changes in the healthcare landscape. SLEC will also circulate memoranda and conduct briefings for Directors to stay abreast of changes.

The Board Members serve on the Board as volunteers and do not receive any renumeration or benefits.

Staff remuneration is subject to remuneration guidelines approved by the Board of Directors and sector salary guidelines.

SLEC does not have paid staff who are close members of the family of the Executive Head or Board members who receive more than \$50,000 during the year.

The Nominations Committee reviews the Board and its performance.

At the annual general meeting held yearly, there will be staggered retirement of the Board Directors, and appointment of new Directors who will serve the three-year term unless specified. The tenure limit of each director is 10 years, except for Treasurer/ Chairman of Finance Committee. Adoption of Director Competency Mapping is used to identify the gaps in skillsets and knowledge in the Board of Directors to meet the evolving needs of the organisation.

Audit, Risk and Governance Committee

The Audit, Risk and Governance Committee comprises Mr Choo Eng Beng (Chairman), Mr Ho Kuen Loon, Mr Ho Tuck Chuen, Dr Li Haobin, Dr Yap Chee Meng and Mr Yeo Ek Khuan. All Committee members have recent and relevant accounting or related financial management expertise of experience. The Committee assists the Board in fulfilling its oversight and fiduciary responsibilities to act in the interest of St Luke's ElderCare.

The Committee's responsibilities include:

- Reviewing and evaluating the effectiveness and adequacy of internal control systems to ensure the integrity and confidentiality of critical information
- Ensuring the adequacy of disclosure of any public financial reporting.
- Reviewing the effectiveness of internal control to mitigate operational, financial, and business risks
- Reviewing the robustness of the corporate governance structure
- Reviewing the internal and external audit plans and reports

Audit is a critical undertaking of the Committee. The Committee reviews recommendations by appointed auditor Moore Stephens LLP pertaining to areas such as asset management, compliance controls, operational procedures, procurement and payments and risk management.

The annual audit carried out by Moore Stephens LLP focuses on key areas of risk, particularly those with high potential for material inaccuracies. These are areas where significant judgement in relation to accounting are made by the management as well as issues from the previous year's audit (where relevant). The audit covers analytical review and review of financial statements, assessment of control protocols, identification and assessment of risks, review of audit findings and procedures adopted, as well as understanding of the business and accounting process.

In the financial year under review, the Committee met three times to review recommendations by Moore Stephens LLP. The audit report for this financial year concluded that there were no exceptions to report.

The Committee will continue to ensure the highest possible level of organisational integrity within SLEC.

Finance, Investment & Procurement Committee

The Finance, Investment & Procurement Committee comprises Ms Ginger Hsiao (Chairman), Mr Wan Kum Tho, Mr Yeong Zee Kin and Mr Lee Chee Yeng. Mr Lee Chee Yeng ceased to be a member with effect from 30 Sep 2020. All the Committee members have recent and relevant finance or investment management expertise or experience. The Committee provides advice to the Board and reviews SLEC's financial performance, annual budget, and expenditure with the aim of:

- Approving investments and other financial matters
- Overseeing annual budget preparation
- Reviewing and approving tenders with management
- Updating the Board of Directors on financial decisions made

In line with its mandate, the Committee met four times to review project tenders, the annual budget and investment matters.

Fundraising Committee

The Fundraising Committee comprises Mr Alfred Wong (Chairman), Mr Choo Eng Beng and Mr Foong Daw Ching. All the Committee members have recent and relevant fundraising expertise or experience. The Committee advises the Board and Management on fundraising matters.

The Committee provides oversight to Management on fundraising strategies and plans and ensures that ethical fundraising is practised.

Beyond generating ideas and providing oversight, the Committee expands SLEC's access and outreach to potential donors, funders, and sponsors by leveraging the influence of its members.

The Committee keeps Board Members updated on fundraising activities. In the financial year under review, the Committee held three meetings which were attended by all members.

Human Resource Committee

The Human Resource Committee comprises Professor Ho Yew Kee (Chairman), Ms Lim Ai Ling, Professor Neo Boon Siong and Mr Wong King Yoong. All the Committee members have recent and relevant human resource expertise or experience. The Committee assists the Board by providing a strategic and principled perspective on the design and implementation of SLEC's human resource policies.

The Committee's responsibilities include:

- Overseeing appointments, development path, compensation, and performance of Senior Management
- Reviewing succession planning for key management positions
- Reviewing policies related to the recruitment, training, development, and retention of staff
- Setting and approving bonus and compensation packages for all staff

For the financial year under review, the Committee met twice to review the organisation's human resource objectives. Subsequently, the Committee worked closely with the Management of SLEC to ensure the successful implementation of the revised objectives.

Medifund Committee

The Medifund Committee comprises Mrs Wee Wan Joo (Chairman), Ms Chua Ee Cheng and Dr Wong Loong Mun. All the Committee members have the relevant expertise or experience to ensure that disbursements are made in accordance with Medifund objectives and guidelines.

Specifically, the Committee is tasked with evaluating and approving Medifund and Medifund Silver applications from eligible clients and monitoring the administering of payments out of the Medifund account of SLEC.

The Committee assesses applications for assistance with healthcare bills. Its decisions are based on criteria such as the socioeconomic background of the applicant's immediate family members, the size of the bill incurred and the outstanding balance.

For the financial year under review, the Committee met five times. It approved disbursements to ensure that clients' healthcare bills are paid in a timely manner.

Missional Care Committee

The Missional Care Committee, which was established in October 2020, comprises Mr Foong Daw Ching (Chairman), Ms Khor Siew Khim, Mr Steven Loh, Pastor Albert Low, Pastor David Yap, and Mrs Mona Chia-Lee. All the Committee members have the relevant expertise or experience to ensure relevance, capability building and fulfilment of SLEC's missional strategy.

Specifically, the Committee is tasked with reviewing and recommending new church partners; reviewing and supporting the pastoral care approach and programming for the holistic care of SLEC clients, caregivers, and care staff; and considering any other matters as may be defined by the Board.

The Committee assists the Board in leading Board and Senior Management Strategic Reviews to ensure relevance of SLEC's missional strategy. This is in relation to national and regional landscape and demographics, connections, capacity and capability building, leading to direction and policy prescription in the engagement of client and caregivers, partners, and staff in the fulfilment of SLEC's missional strategy.

For the financial year under review, the Committee met twice to review and discuss the implementation of the missional care strategy with the management and pastoral care team.

Nomination Committee

The Nomination Committee comprises Mr Timothy Teo (Chairman), Professor Ho Yew Kee, Ms Jacqueline Poh and Mrs Wee Wan Joo. All the Committee members have recent and relevant corporate governance expertise or experience to assist the Board in ensuring that SLEC complies with the revised Code of Governance for Charities and Institutions of a Public Character.

The Committee's responsibilities include:

- Leading the process for all nominations pertaining to the appointment of Board committees and persons invited as members of the Board
- Reviewing the structure, size, and composition of the Board to ensure compliance with the guidelines of the Charity Act and making recommendation on any change needed in these aspects to the Board
- Evaluating the skills and knowledge required for all nominees to the Board, taking into consideration the current composition of the Board
- Reviewing succession plans for the Board

In the financial year under review, the Committee reviewed the current Board and its performance. In particular, the Committee examined the nominees to the Board, the structure of the Board for compliance with the Charity Act and the composition of the Board committees. Following the reviews, the Committee offered advice and made recommendations to the Board.

Programmes, Services and Care Risk Committee

The Programme, Services and Care Risk Committee comprises Ms Jacqueline Poh (Chairman), Dr Chan Kin Ming, Adj Asst Prof Kelvin Koh, Ms Carol Liew and Mrs Wee Wan Joo. All the Committee members have recent and relevant expertise and experience in senior activity programmes and operations to provide oversight and guidance on programme and service development that aligns with SLEC's Mission and Vision. Additionally, they identify, manage and mitigate care risks arising from the operations in the senior care centres, nursing home and home care.

The Committee's responsibilities include:

- Providing oversight of programme and service development to ensure that they are in line with the Mission, Vision and objectives of SLEC
- Providing oversight on the operational implementation of programme and service delivery mechanisms
- Providing oversight on programme evaluations and service quality
- Monitoring and assessing outcome of programmes, ensuring clear definition of intended outcome of each programme
- Working with Management to identify, monitor and manage clinical, operational, and administrative risks linked to our programmes, services, and care
- Providing updates to the Board on the risk registers with mitigating measures

Whistle-Blowing Policy

SLEC is committed to lawful and ethical behaviour in all its activities, and requires that its Directors, Management, staff, volunteers and consultants conduct themselves in a manner that complies with all applicable laws and internal policies. 

WEATHERING THE CHALLENGES

On 7 April, our elders and staff bid farewell during the temporary closure of our centres, following the government's Circuit Breaker measures. At SLEC, this meant a sudden and an abrupt disconnect for all our elders from our 23 centres.

It was the first time most of our elders and staff would be away from the centres for a month. Although many felt sad from parting, they understood that these measures were necessary to keep everyone safe.

Our centres might have been closed but our 'service to elders' continued, as elders brought home home-based learning materials that were lovingly prepared by our staff.

The exception to this was the opening of two whitelisted centres – Hougang Meadow and Rivervale Centres which were operational from 7 April 2020 and 4 June 2020 respectively, to serve elders identified with high care needs.

Beyond providing support to our elders, we also communicated and provided support to our staff to meet their needs during the closure of the centres, where regular engagement and online training sessions were arranged.

Together@SLEC


Appointed Care Ambassadors from a multidisciplinary team of care staff, counsellors and therapists formed the Together@SLEC team, conducting virtual engagement sessions for our elders through 1-hour activity programmes titled "Stay Home with SLEC" on Facebook Live and YouTube channels.

Four caregiver forums, with more than 100 caregivers participating, were organised via Zoom. Caregivers surfaced concerns they had to a multi-disciplinary team comprising our centre managers, nurses, therapists, counsellors, and chaplains who responded with advice and encouragement.

Tele-rehab

On the rehab front, 30-minute daily maintenance exercises were conducted via Zoom during the Circuit Breaker. Tele- and video checkin sessions, where needed, were conducted with elders to ascertain if an elder required onsite home therapy sessions due to functional deterioration.

Volunteer Chats

In May 2020, we initiated our first virtual introductory session for new volunteers. Named "Virtual Kopi Talk with SLEC", the sessions were one of the ways we dialogued with those interested in volunteering and connecting them with like-minded peers for volunteerism efforts.

Health Talks

On 1 June 2020, we held our first health talk live stream session, to support and connect with more than 40 volunteers and partners on Zoom. Hosted by our in-house dietician, attendees learnt how to boost immune system through healthier food alternatives and useful groceries shopping tips. Subsequent virtual talks touched on topics such as Osteoporosis-Bone Health and Diet and Diet Management for High Blood Pressure.




2nd Pastor and Church Leader Forum

Organised in June 2020, the forum was attended by 18 representatives from 12 SLEC church partners. The forum served to inform and update existing and new church partners about developments and ministry to elders and staff at SLEC, sharing of best practices by one another, such as the effectiveness of online engagement via Zoom, and to explore new areas of partnerships.

Our first virtual appreciation for partners took place in January 2021. Titled "Igniting Hope", the event served to thank volunteers, donors and partners who have supported SLEC over the years. Through the event, of which 140 participants attended, we shared the impact of our work and presented further opportunities to reach out and enrich the lives of our elders.

Community of Care

Our community partners play a significant and strategic role in bringing sustainable benefits to our elders.

Community partnerships such as those with the Health Promotion Board (HPB) and SG Cares benefitted our elders through weekly exercise activities such as chair Zumba. stretch band exercises, low resistance aerobics, and terrariumbuilding and ukulele workshops respectively.

SLEC's partnership with Tan Tock Seng Hospital (TTSH) for the CONNACT (Collaborative model of care between Orthopaedics and allied health professionals' trial) programme also improved the quality of life of elders suffering from osteoarthritis (OA) of the knees. The programme involved regular therapy sessions at our day rehabilitation centre run by our therapists, after acquiring new knowledge in OA knees management with the training support provided by the TTSH team.

Adjunct Appointments with Tertiary Institutes

With the goal to build, cultivate and attract communities in understanding and joining the sector, key executive staff members such as our Chief Executive Officer, A/Prof Kenny Tan and Senior Director of Nursing Services and Academic Director, A/Prof Edward Poon continued to take up joint appointments with the Singapore Institute of Technology (SIT). Some of the responsibilities of the appointment include curriculum development, teaching, mentoring of students and supervising of final year projects.

Supporting and Equipping Staff

In view of the safe distancing measures, SLEC's Townhall also took on the virtual platform to update staff on the COVID-19 situation and the organisation's response, and understand the sentiments of staff and how they coped with working from home. In addition, our Pastoral Care and Church Partnerships department held daily chapel sessions and circulated materials to encourage and support staff mental health. New staff were also equipped through the New Hires' Orientation Programme (NHOP), a synchronous online training for those who joined us during the pandemic. NHOP became even more important in the current climate, to ensure that we continued to engage and equip our new staff with the relevant competencies to perform their job duties and adapt to our organisation.

Equipping the Future Generations

As part of a 3-year collaboration, SLEC together with Temasek Polytechnic (TP), offered the Specialist Diploma in Gerontology (Optimal Ageing Practice). 10 SLEC staff with subject matter knowledge, qualifications and industry experience were appointed as TP's Adjunct Lecturers. They also served as Practicum Supervisors to mentor the 143 students from the specialist diploma in the past year.

RE-DEFINING CARE FOR IMPACT

SLEC recognises the opportunity we have in creating new value for care recipients, in alignment with the current healthcare climate and our vision to transform community care.

We leverage our positioning to build models of care inspired by customisation and bring innovation to our active ageing concepts.

SLR@AMK: OUR FIRST RESIDENTIAL CARE FACILITY

On 4 May 2020, SLEC officially opened our first residential care facility, St Luke's ElderCare Residence @ Ang Mo Kio (SLR@AMK). The 189-bedded residence which spans 6 levels with 12 households, includes a day care centre and day rehabilitation centre.

SLR@AMK goes beyond basic nursing home care, by providing integrated care as an IOP (Integrated Operations Provider), delivering centre-based services, homebased services, community-based services and residential-based services.



Meet Extraordinary Needs

SLR@AMK opened during the COVID-19 pandemic in May 2020. Within the early days of operation, we were called to support another nursing home, by accommodating their residents and caring for them when residents had to live apart and space was needed for safe distancing.

Strengthening Our Measures

Internally, we also looked to strengthen our measures for better infection prevention and control at the beginning of the pandemic. Infection control and PPE and hand hygiene practices were strictly put in place, and staff complied with PPE and hand hygiene practices. A pandemic drill exercise was also conducted, to familiarise staff with the procedures, in the event of an emergency.

SLR@AMK: CARE APPROACH

Aptly termed as a 'residence' instead of 'nursing home', we strive for our residents to have a 'home away from home' experience. They are empowered to make choices according to their interests and lifestyle. We aim to provide holistic and clinical care for our residents to age gracefully through our services, programmes and activities.

- Naming conventions such as 'household' instead of 'wards', 'care partner' instead of 'staff'.
- Provision of kitchen appliances at every household that will enable residents to make their own tea breaks and snacks.
- Bedrooms are furnished with spacious wardrobes, pressure-relief mattresses, and wooden-framed nursing beds for personalised and comfortable space.







OUR FIRST ACTIVE AGEING HUB

Our Active Ageing Hub (AAH) at Bishan, slated to open in phases from 1 Oct 2021, will be our latest facility offering a wide range of active ageing programmes, day care, day rehabilitation and assisted living services for the elders in our community.

Through ageing-friendly activities such as customised fitness programmes, workshops on technology inclusion, nutrition, art, and other activities, we hope to educate, empower, and engage our community-dwelling elders.

The AAH will also take on a partner-led approach where we rely on the expertise of our community partners, including volunteers, healthcare providers and other organisations, to join us in curating programmes to benefit the Bishan community.

Food with Love RAISED \$50,939

During Phase 2, we partnered 20 Food and Beverage (F&B) establishments and organised the #FoodWithLove fundraising project. This campaign not only supported SLEC financially, but also the F&B partner establishments that were suffering from a loss of business during the Circuit Breaker. By making a \$100 donation, donors received \$100 F&B vouchers in return to spend at the 20 F&B establishments.

Parents were roped in to help raise funds online, while the children created artworks and made care packs for our elders. A few preschools also prepared performances to engage our elders. Part of the project was to guide our elders to make keychains, which were subsequently sold at various events and online platforms to raise funds.

The "Donate Your BBT Fund" was set up on 22 April 2020 riding on the news of the closure of bubble tea stores. The campaign, which was widely shared on our social media, ran for two months.





Hongbao Project 2021 RAISED \$164,243

We partnered with 76 schools and churches for the St Luke's Hongbao Project 2021. While schools received the physical red packets for each student to donate, the churches were encouraged to give online through QR Codes in their church bulletins.

Stories and Rhymes of My Youth



Finalist, Best Active Ageing Programme, 8th Eldercare Innovation Awards 2020 This initiative enabled our elders to tell the history and retrospective of their lives. Through these sharings, new connections with caregivers were forged and precious memories were preserved.

Community Re-Integration



Finalist, Best Rehabilitation Programme, 8th Eldercare Innovation Awards 2020 This initiative engages elders from our day rehabilitation service and serves as a bridge between rehabilitation sessions and reallife settings. Through exposure of elders to outdoor scenarios, our therapists gained better understanding of needs in order to deliver person-centric rehabilitation. The goal was to optimise successful integration of our elders back into the community.

Implementing Exercise for Strength (EFS) Group Exercise Class in Day Rehabilitation Centres for Frail Elders



Clinical Quality Improvement, AIC Community Care Excellence Awards 2020 Designed to help frail elders regain strength and minimise risk of falls, this initiative utilises pneumatic machines for safe strength-training, balance activities and pre-training and posttraining. Improved strength, endurance, agility, balance, and safety in walking were some key outcomes.

Creating a Homely and Cosy Dementia Day Care Centre



Client Experience Improvement, AIC Community Care Excellence Awards 2020 This initiative sought to create a conducive environment for elders with dementia, by improving the centre's physical environment and creating small clusters for activity engagement. For example, having an outdoor patio for elders to connect with the outdoors, have a safe wandering space and interaction with children and neighbours at the playground.

SingHealth Quality Service Awards 2021 This large-scale project brought together staff from all centres, disciplines, and departments. Of these, 165 staff were trained and designated as Care Ambassadors to purposefully engage elders and continue to deliver care even while our centres were temporarily closed.


